## Purpose and Legal Basis for Processing Personal Data

The collected data will be used exclusively for the purposes of assigning a buddy to the participants and sending information via e-mail within the scope of the Buddy Programme. The International Office will share the following participant's information

with their respective buddies: First and last name, e-mail address, degree programme and home country (for tutees). Further personal data will not be passed on. The International Office will send its communications to the participants of the Buddy Programme as blind copies via an Outlook e-mail list. The lawfulness of the data processing lays in the data subject's consent according to the EU GDPR, art. 6, Para. 1 lit. a.

#### Data storage & erasure

The data will be collected using an electronic form on the website and will be sent automatically to the International Office per e-mail. The International Office will storage the received data (including the email address) in its databank and delete the e-mail afterwards. Participants' data shall be deleted in case the participants are no longer available as tutors/tutees or if they withdraw their consent; however, not later than 2 years from the date of the submission of the registration form. The same term applies to the Outlook e-mail list.

## Rights of the data subject

Based on the processing of your personal data, you have the right of access (Art. 15 GDPR), the right to rectification (Art. 16 GDPR), the right to erasure (Art. 17 GDPR), the right to restriction of processing (Art. 18 GDPR) and the right to object (Art. 21 GDPR). In addition, you can contact the data protection officer (datenschutz@uni-erfurt.de) of the University of Erfurt with a complaint. Without prejudice to any other administrative or judicial remedy, you have the right to lodge a complaint with a supervisory authority – in the State of Thuringia, it is the *Thüringer Landesbeauftragte für den Datenschutz und die Informationsfreiheit* (TLfDI) (e-mail: poststelle@datenschutz.thueringen.de).
