Purpose and legal basis of the data processing, deletion

For the form "Order for the production of reproductions" we need the following personal information to fulfill the order:

- Providing your telephone number (for further inquiries) and user number is voluntary

Your data will be stored for a period of 10 years in accordance with the Annex Storage Periods, "General Part", point 2.3 of the "Guideline on the storage of documents in the administration of the Free State of Thuringia."

Rights of data subjects

As a data subject, you have the following rights:
