Notice:

We would like to inform you that if personal data is published on the internet, it can be accessed by anyone worldwide - also with the help of "search engines" (e.g. Google). Archive functions of search engines (see e.g. www.archive.org) may still allow access to the data even if it has already been removed or changed from the above-mentioned internet offers of the university. Editing of the images (in the archive function) only takes place if, for example, a change in brightness, a change in the size of the image or a different background is necessary for reasons of better visibility. Other edits are not intended.
