

## **Payment Information**

All students are obliged to pay the semester contribution and the tuition fee on time in order to remain enrolled at the University of Erfurt. For the summer semester 2019, the deadline for the payment of fees is February 01, 2019, meaning that the University of Erfurt must have received both payments by January 31, 2019 at the latest. Please note that it often takes 2-3 days for German banks to complete transactions and that it is your responsibility to make sure your payment reaches the university in time. Otherwise, you will be charged (at least) a late fee of EUR 20.00 if your semester contribution is late.

## **Program Information**

#### **Basic and Language Module**

Rules and Regulations ("Studien- und Prüfungsordnung") prescribe that **you have to collect 9 credits** in this module. This means that you can either take three courses with 3 credits each (3+3+3=9) or one course with 3 credits and one with 6 credits (3+6=9). **The sum of credits you earn needs to equal the figure 9 in any case** (i.e., 6+6=12 is not possible). On top of that, should you wish to take more courses in this module, you are, of course, free to do so.

#### **Specialization Modules**

- By the end of their study period (third semester), all students must complete two specialization modules by
  obtaining a minimum of 9 credit points each in both modules (total of 18 credit points).
- You are, of course, free to audit additional courses with the instructor's permission, but be aware that you can still
  handle the course work of your mandatory classes.
- It is not possible to substitute credits earned in one module for credits earned in another module or to take a course twice if you have already passed the first time.
- Only for CSMP students: CSMP students are required to complete the courses designed for this program by earning 9 credits in each CSMP module (compulsory CSMP I courses and elective CSMP II courses).

## **Program Information**

#### **Independent Study Units**

Independent Study Units (ISUs) aim at deepening the students' knowledge in certain public policy fields at an individual pace and are geared to individual needs. They can be a means of allowing students to equalize differing levels of prior knowledge.


Subject to approval by the academic mentor, the Brandt School's academic staff as well as faculty members or professors of the Faculty of Economics, Law and Social Sciences or other faculties of the University may be approached as supervisors for an ISU. According to Paragraph 11, Section 3 of the MPP Examination and Study Rules, an independent study agreement must be signed by both the student and the instructor at the beginning of the semester (within the course registration deadline) to receive credit points for an ISU. In this independent study agreement, the student pledges to work on an agreed topic and corresponding questions regularly and independently as well as to spend the necessary amount of time to reach the learning goals within a given time frame. To check the learning progress and to give the instructor an overview of the working status, specific assignments are given and regular meetings should be agreed upon.

ISUs can be pursued in the Basics and Language Module and in the Specialization Modules and substitute for a 3 credit point seminar.

If you are interested in enrolling in an Independent Study Unit, please discuss its contents and how it fits into your study plan with your academic mentor and contact MPP Program Coordinator Theresa Dabla for more details regarding enrolment and the independent study agreement.

# Policy Analysis Module Introduction to Public Policy \*

#### **Keywords**

Policy-making; policy analysis; policy cycle; policy memorandum

#### **Course Description**

This mandatory first-year lecture course will introduce students to theories, concepts, terms, and methodologies of public policy. It provides an overview on the basic procedures and areas of policy analysis, with a focus on democratic policy-making. By the end of this course students will be able to perform policy analyses based on a thorough knowledge and understanding of key theoretical approaches and policy debates. As policy analysts, students will learn to advise policy-makers, non-government organizations, and societal actors on very different subject matters, regions, or working environments. Emphasis is placed on current debates and on gaining a comparative cross-national perspective on these issues and their consequences on policy-making. The course will be complemented by a workshop on "Research and Writing for Public Policy", to prepare students for the writing of a policy paper on a self-selected topic.

#### **Course Description**

This workshop is part of the "Introduction to Public Policy" lecture course and mandatory for first-year students. The course introduces students to the essentials of research and writing for public policy, such as finding the right literature, properly citing sources, and formulating and presenting persuasive arguments. It aims to prepare students for the writing of a policy paper, as part of the grade for the "Introduction to Public Policy". To create a workshop atmosphere and allow for small group exercises, the lecture class will be divided into two groups that meet at different times (see schedule above). The groups will be assigned during the initial sessions of "Introduction to Public Policy".

#### **Course Description**

The objective of this course is to provide students with the economic tools to conduct policy analysis. Rather than presenting Economics as a scientific mathematical field of study, students are encouraged to see Economics like a new language that policy professionals must speak. Having said that, the course then deals with the basic grammar of Economics, such supply and demand and the way markets work in the real world. Policies then are analyzed by the effects they have on the markets, identifying winners and losers. Here Economics interacts with politics, interest groups, lobby, regulation and so on. That is, students

should not look only at the economic aspects of the phenomena studied, but within the context of a country or region where people lived. Moreover, students of public policy also need to be able critically assess the limits of an economic perspective.

#### **Course Description**

The central aim of this course is to give students the opportunity to examine and compare concrete public policies across a variety of national and sub-national contexts. Building on the "Introduction to Public Policy" and the theories and approaches presented there, the course will provide a survey across diverse policy areas, including economics, public health, migration, and foreign policy, to name just a few areas.

The course will also introduce appropriate methods for comparative policy analysis. Overall, the course aims at teaching an advanced understanding on how to compare public policy across countries as well as key policy issues in various societies with a special focus on contemporary policy concerns.

#### **Course Description**

This course seeks to familiarize students with the theories and practical concepts of leadership and political advocacy. It is designed to capacitate students to work successfully in management positions, to direct and coordinate human resources, and to advocate issues successfully in a political context.

Leadership is a process of influencing and supporting others to work enthusiastically towards achieving objectives. A leader is the catalyst that transforms potential into reality. Good leaders develop through a continuous process of self-study, education, training, and experience. In this context we will discuss major factors in and principles of leadership and discuss implications for strategic management and political leadership.

In the context of political advocacy, we aim to better understand the complexity of leadership in public and political environments. Political advocacy can include many activities that a person undertakes such as media campaigns, lobbying, or public speaking which need to be aligned to ensure optimal outcomes. The assessment of specific examples will allow us to draw lessons on how to best align those activities to optimize political advocacy.

At the end of the course, participants should be able to apply a variety of leadership styles; identify leadership mistakes and be able to avoid them; distinguish between private, public, and non-profit leadership styles; transfer good practice examples of public and political leadership into practice. Furthermore, the students will have the opportunity to learn more about their own leadership skills and styles. A professional consultant will join us to improve our leadership skills.

#### **Course Description**

Social entrepreneurs are entrepreneurs with a social mission; the generation of profits is not the primary goal of the social entrepreneur. Reversed, this does not mean that the social entrepreneur considers the generating of income as being of no value or interest. The social entrepreneur differs fundamentally from the traditional, purely altruistically acting philanthropist because generating income for the financial security of a socially motivated project is regarded as an important means to an end. Because the field of social entrepreneurship is interdisciplinary and in its infancy, the course will be introductory putting emphasis on developing practical skills.

We will develop a better understanding of the meaning and various forms of social entrepreneurship through lectures, case studies, and working on a self-designed project. Students will be expected to develop a business model canvas for a (fictional) social enterprise.

At the end of the course, students can expect to have gained an understanding of the field of social entrepreneurship and to have grasped many of the opportunities, challenges, and issues facing social entrepreneurs. By developing a business model canvas for an own (fictional) social enterprise, students will gain a thorough understanding on how to apply new knowledge into practice.

This course introduces students to the theory and practice of public governance applied to the context of institutional and public sector reforms in developing countries, balancing historical, theoretical and practical aspects. The first part of the course will discuss the emergence of the concept of governance against the backdrop of development theory. It will analyze the changing views on the role of the state leading to the contemporary emphasis on institutions and governance. The second part will explore the theoretical tenets of the governance framework applied to actual cases involving policy-making and implementation. By looking into cases such as participatory budgeting in Brazil or the management of a Public-Private Partnership (PPP) in Italy, for example, this part will uncover the challenges of improving governance structures in the context of public sector reforms. It will be focusing, particularly, on issues concerning participation, accountability, legitimacy, power, and coordination. The third part comprises the practical

application of the concepts learned in the first and second parts. Governance-related databases such as World Governance Indicators (WGI), Institutional Profile Database (IPD), The Global Competitiveness Report (GCR), and Freedom in the World Index will be introduced to subsidize the analysis and interpretation of the current issues and challenges faced by different countries. Students will hold presentations to analyze specific cases in their own countries, contributing to the discussions in class and supporting cross-context comparison.

The field of public governance is extremely wide and this course will introduce concepts and cover the most relevant debates. Its objective is to provide students with fundamental theoretical knowledge that can be readily used for the evaluation of public governance issues, backed with 'hard evidence' extracted from databases and with the use of governance indicators.

### **Course Description**

Conflicts are ubiquitous and consequential social processes. Therefore it might be surprising that conflict studies are a rather young area of research within the social sciences. Subscribing to the project of modernity, sociologists as well as political scientists have tended to consider conflicts as disturbances, anomalies or even malfunctions of social life, which would disappear as men and society moved up the evolutionary scale. Therefore research revolved around the causes and the containment of conflicts.

Contrary to this common approach, the social dynamics of conflict itself will be at the heart of this introductory course. The first part introduces classic and recent social sciences theories of conflict. Against this theoretical background, we will, in the second part of the course, study the empirical evolution of conflicts since 1945 from a historical perspective.

# **Course Description**

A quarter century after the official introduction of Common Foreign and Security Policy (CFSP), the EU still grapples with an autonomous global role. Between dominating world powers and the desire of its member states to retain one of the last domains of their national sovereignty, there is not much room for what has come to be called European foreign policy. This course looks at how the EU has developed its tools to become a more serious actor in global politics and how it has

deployed them in one concrete case of conflict resolution, i.e. the Iran nuclear negotiations between 2003 and 2015.

# **Course Description**

Gender plays an integral role in the ways in which violent conflict and its aftermath affect women, men, girls, boys and other gender identities differently. Conversely, societal gender expectations themselves also can increase or decrease violent conflict. The course will examine the theoretical underpinnings of the relations between gender, conflict and peace, as well as examine in more detail militarized constructions of gender identities, conflict-related sexual and gender based violence, as well as gender in the context of post-conflict peacebuilding measures such as transitional justice, reintegration of former combatants and security sector reform.

This project group is conducted in collaboration with the NGO Oikodrom – the Vienna Institute for Urban Sustainability (<a href="http://www.oikodrom.org/">http://www.oikodrom.org/</a>) and the communications agency Oikoplus (<a href="http://www.oikoplus.com/">http://www.oikoplus.com/</a>), both based in Vienna, Austria.

The objective of this project group is to support a community and urban development NGO based in Vienna with specific projects in Brussels and Latin America. The client, the Vienna Institute for Urban Sustainability, OIKODROM, and its private spin off OIKOPLUS together with other stakeholders will soon start a community development project in Brussels. The objective of the project is to improve the conditions of 'problematic' neighborhoods to generate the conditions for a sustainable and prosperous community. At the same time, the client will be applying for new Horizon 2020 call for another urban development project in Latin America.

Willy Brandt students are needed to help in the early stages of project development (design funding, implementation). The Brandt Commission was established in 1977 and chaired by the former Berlin mayor and German Chancellor Willy Brandt, the patron saint of the Brandt School in Erfurt. The commission was concerned about the North-South divide and perceived the development of the so-called South as an important if not crucial pre-condition for overcoming economic and social disparities worldwide and for avoiding humanitarian catastrophes in the future. The Brandt reports offer innovative ideas, recommendations and thoughts which are of high topicality 40 years after.

The project group will take this as a starting point to develop a panel topic for the ecpr Conference in Wroclaw, Poland in September 2019 (<a href="https://ecpr.eu/Events/EventDetails.aspx?EventID=123">https://ecpr.eu/Events/EventDetails.aspx?EventID=123</a>).
