## **Payment Information**

All students are obliged to pay the <u>semester contribution</u> and the <u>tuition fee</u> on time, in order to remain enrolled in the MPP. **For winter semester 2024/2025**, **deadline for paying the fees is July 15**, **2024**, meaning that the University of Erfurt must have received both payments on its accounts by that date at the latest. Please note that it often takes around 2 working days (Monday to Friday) for German banks to complete transactions. It is your responsibility to make sure that your payments reaches the university in time. If your semester contribution is late, you will be charged a late fee of EUR 20.00.

Payment information for the semester contribution for the winter semester 2024/2025 is sent to your student e-mail address. In your (online) transfer order, please be sure to provide all the information given in the payment information to ensure that your payment is transferred to the correct account. It will otherwise not be possible to attribute your transaction to the Brandt School and following-up on the payment will mean substantial administrative extra work for you, as well as the Brandt School staff.

For the **tuition fee**, in case you have a blocked account (with only a limited monthly amount to be deducted), please start to transfer suitable installments of min. 500 EUR already well in advance, in order to make sure that the due amount is received in total by the University of Erfurt by the end of the re-registration deadline mentioned above at the very latest.

Your student ID card (thoska) can only be re-validated for the new semester after all your payments (including late fee, if applicable) have been received.

#### **About the Instructor**

Before joining the Willy Brandt School, **Prof. Dr. Andreas Goldthau** held a Chair in International Relations at Royal Holloway College, University of London, and he is Research Group Lead at the Institute for Advanced Sustainability Studies. He is also Associate with the Geopolitics of Energy Project at Harvard University's Belfer Center for Science and International Affairs. Previously, he served as Professor at Central European University's School of Public Policy, as Adjunct Professor with John Hopkins' MSc program in energy policy and climate, and held shorter appointments at the Paul Nitze School of Advanced International Studies at Johns Hopkins University, the RAND Corporation and the German Institute for International and Security Affairs. #### **Course Description**

The central aim of this course is to give students the opportunity to examine and compare concrete public policies across a variety of national and sub-national contexts. Complementing "Introduction to Public Policy" and the theories and approaches presented there, the course will provide a survey across diverse policy areas, including economics, public health, migration, and foreign policy, to name just a few areas. The course will also introduce appropriate methods for comparative policy analysis. Overall, the course aims at teaching an advanced understanding on how to compare public policy across countries as well as key policy issues in various societies with a special focus on contemporary policy concerns.

#### **About the Instructor**

**Prof. Dr. Achim Kemmerling** is the Gerhard Haniel Chair of Public Policy and International Development and currently the vice director of Willy Brandt School of Public Policy. #### **Course Description**

## Management and Leadership (6 ECTS)



#### **Course Description**

This course seeks to familiarize students with the theories and practical concepts of leadership and political advocacy. It is designed to capacitate students to work successfully in management positions, to direct and coordinate human resources, and to advocate issues successfully in a political context. Leadership is a process of influencing and supporting others to work enthusiastically towards achieving objectives. A leader is the catalyst that transforms potential into reality. Good leaders develop through a continuous process of selfstudy, education, training, and experience. In this context we will discuss major factors in and principles of leadership and discuss implications for strategic management and political leadership. In the context of political advocacy, we aim to better understand the complexity of leadership in public and political environments. Political advocacy can include many activities that a person undertakes such as media campaigns, lobbying, or public speaking which need to be aligned to ensure optimal outcomes. The assessment of specific examples will allow us to draw lessons on how to best align those activities to optimize political advocacy. At the end of the course, participants should be able to apply a variety of leadership styles; identify leadership mistakes and be able to avoid them; distinguish between private, public, and non-profit leadership styles; transfer good practice examples of public and political leadership into practice. Furthermore, the students will have the opportunity to learn more about their own leadership skills and styles. A professional consultant will join us to improve our leadership skills.

#### **Course Description**

The Public Policy degree program (MPP) includes a mandatory internship as one requirement for completing the degree. Primary purposes of the internship are the opportunity to apply the knowledge and skills from the classroom in a work setting, to give students a practical perspective on policy analysis and public management and to help them compare their abilities and interests with requirements in particular fields of public policy.

Internships may be conducted in government agencies, international organizations, NGOs, or other non-profit or for-profit organizations. The job description must show that the work assigned to the intern will be relevant to public policy analysis and/or management. Internships must comprise at least 180 hours, 5 of which may be used for writing the internship report. Typically, the internship will be conducted during the summer break between the second and the third...

...semester (mid-July to mid-October). The hosting agency must name an individual person, responsible for supervising the intern and for communicating with the Brandt School if needed.

In order to receive credits for their internship, students have to submit an internship report of 4-5 pages via moodle, no later than 30 days after the last day of the internship. ## **Elective Courses**

#### **Specialization Modules**

- Out of the four specializations offered, you must have completed two of the four specializations on offer by the end of the study period (i.e. at the end of your third semester)
- To complete a specialization, you need to attend (at least) two seminars (for 3 credits each; pass/fail) and do one module exam (for an additional 3 credits and a grade) in one of the courses visited.
- You are free to participate (for credits) or audit (without credits) additional courses with the instructor's permission. However, first and foremost be sure that you can handle the course work of your mandatory classes.
- It is not possible to substitute credits earned in one module for credits earned in another module.
- It is also not possible to re-take a module exam that you have already passed (with a grade of 4.0 or better).

#### **Course Description**

This course on Social Innovation Management undertakes a comprehensive exploration of the dynamic intersection between societal challenges and innovative solutions within contemporary organizational landscapes. In an era characterized by rapid technological advancements, global interconnectedness, and escalating social environmental problems, the imperative for effective social innovation has never been more pronounced. This course is curated to equip participants with the theoretical frameworks, strategic insights, and practical tools essential for navigating the complex terrain of social innovation. Through an interdisciplinary approach drawing on management theories, social economy science, and the economics of innovation, participants will delve into the multifaceted dimensions of social innovation, ranging from the identification of societal needs to the design and implementation of transformative solutions and the management of change and innovation processes. Key objectives include fostering a nuanced understanding of the societal context that necessitates innovation, cultivating critical thinking skills to identify novel opportunities, and developing the managerial acumen required to navigate the challenges inherent in socially innovative endeavors. By the course's conclusion, participants will be adept at conceptualizing, implementing, and managing social innovations, contributing meaningfully to the advancement of both organizational and societal goals. The course will be customized to participants prior experiences and organizational contexts for applicability purposes.

#### **Global Public Policy (3 ECTS)**

#### **Course Description**

In today's data-driven world, the effective analysis and interpretation of data play a crucial role in shaping public policy decisions. However, the field of data analytics can be quite challenging for social science and non-technical students. This course is specifically designed for students of the Brandt School with basic or no prior knowledge of computer programming. Python will serve as the primary language for this course, with introductory sessions designed to familiarize students with the basics of programming. Through guided exercises, students will develop proficiency in coding while gaining insights into algorithmic thinking and computational social science. The course will not have weekly inclass lectures; instead, it adopts a blended learning approach, offering a combination of self-paced learning modules via Moodle, interactive micro lectures, hands-on boot camps, and online meetings. Students will have access to various resources. including lecture materials, tutorials, coding exercises, and discussion forums via Moodle. In addition, selected in-person meetings will provide opportunities for collaborative learning and practical application of concepts.

The course is part of a larger project titled 'Computational Social Science for Public Policy' and is offered in two parts. The first part is offered in the Summer Semester of 2024, while the second and advanced level of the Data Analytics course will be offered in the following winter semester of 2024. #### **Course Description**

In this course, students acquire knowledge and competences concerning the human responsibilities of businesses, which are gaining increasing importance in German and international law. #### **About the Instructor**

He is also Associate with the Geopolitics of Energy Project at Harvard University's Belfer Center for Science and International Affairs. Previously, he served as Professor at Central European University's School of Public Policy, as Adjunct Professor with John Hopkins' MSc program in energy policy and climate, and held shorter appointments at the Paul Nitze School of Advanced International Studies at Johns Hopkins University, the RAND Corporation and the German Institute for International and Security Affairs. His academic interests lie in the international political economy of the low carbon transition, energy security and global energy governance.

#### **Course Description**

In achieving the Paris climate target of "well below 2 degrees" of global warming, the global energy system needs to decarbonize. This means switching from a fossil fuel-based system to one that relies on renewables and low carbon technologies. This seminar will assess key aspects of the energy transition, including the politics of climate change mitigation; questions related to distributional justice; the political economy of national decarbonization; and the opportunities of and barriers to systemic change. It will discuss pertinent aspects including financial flows, the economics of going low carbon, and the role of technology and policy.

#### **Course Description**

This seminar aims to provide a comprehensive introduction to the field of international environmental politics, both in theory and practice. We will analyse how the international community seeks to govern the environmental problems of a transboundary nature as well as discuss best-practice solutions on different scales. Issue-areas covered in this seminar are pollution caused by plastics and pesticides from agriculture, ozone depletion, problems occurring from transboundary water resources, species extinction and zoonotic diseases. Further, we will have a closer look at forest governance, deforestation, and forest certification by simulating an international forest negotiation. Additionally, we will also discuss the civil society perspective from a local perspective, such as 'not in my backyard' protest groups, to a global perspective, thus, the global environmental movement.

#### **Course Description**

In this course, we will discuss aid policies in the European and international context. The perhaps most perplexing debate of our time is whether forms of (official) (development & humanitarian assistance (ODHA) do or do not 'work'. This question besets all types of aid, ranging from smaller (I)NGO interventions to domestic structural policies, bilateral multilateral ODHA. We will put special emphasis on aid giving in situations of conflict and postconflict. Rather than looking for simple and polarizing 'yes' or 'no' answers, we will look for tools and practices how to make aid smarter. To do so we break this big question apart in several steps: we will first briefly discuss the goals of ODHA and how to conceptualize and measure them. For this to make sense we also need to look at major approaches to development (cooperation). Second, we will look at practices of aid giving (types of aid, types of donors, conditionality etc.), to understand what aid agencies actually do. Third, we shift to the consequences of aid giving and how to evaluate these consequences. Evaluation is nowadays a crucial and more and more acceptable tool for making aid policies smarter.

#### **Course Description**

In this course, we will look at policies designed to fight poverty and inequality and their chances and challenges in developing countries. We start with a comparative overview over different types of 'models' and welfare regimes across the world. Then we focus on challenges of welfare state finances such as tax competition and revenue generation. Once we know the revenue side, we look at types of expenditures such as social insurance, social benefits and recent innovations in this area (e.g. unconditional cash transfer programs). Next, we will look at some main areas of social policy (such as health, employment and education). Finally, we look at some related areas such as microfinance. In all sessions, we will not only look at successful and unsuccessful cases, but also at specific challenges in lower- and middle-income countries such as corruption or patronage.

#### **Course Description**

This course introduces students to field experiments as a tool for evaluating public policy. The experimental approach is gaining more and more importance in informing public policy, and having a grasp of the key concepts and methods will therefore become an increasingly valuable skill for students. The course will first cover the method of experimental policy evaluation, i.e. how to design and conduct a randomized controlled trial, and how to interpret the results. We will then discuss experimental approaches to recent issues in economic policy and public economics. Special attention will be given to policy interventions where the experimental design incorporates insights from the behavioral sciences. In the course, students will be asked to come up with an experimental design that can be helpful in better understanding a specific policy issue.

#### **About the Instructor**

**Prof. Dr. Dominik Maltritz** is Professor for International Economics at the University of Erfurt. He studied Business Administration (1994-1999) and Physics (1991-1994) at the University of Göttingen. From 1999 until 2009 he worked at the chair of monetary economics at TU Dresden, where he earned his doctoral degree for his Dissertation "Quantifizierung von Souveränrisiken" in 2006. His fields of interest are: international financial crises, default risks, option pricing theory, capital flow to developing countries and determinants of foreign direct investments, corporate takeovers and choice of location.

#### **Course Description**

This course is about the reasons for growth and economic development in developing and newly industrializing countries, in particular about the influence of and the relation to the external sector of the national economy. We will look at the real economic aspect (exports, imports, etc.), but with a stronger focus on the monetary aspect, i.e. the inward (and outward) flow of capital, such as foreign direct investment. Country risks and the governance of states play an important role in this context. The latter also has a direct influence on economic development and may create feedback effects.

#### **Course Description**

The objective of this course is to introduce students to empirical research in macroeconomics. The focus of the course is on the dynamic and quantitative analysis of macroeconomic and financial shocks (e.g., disruptions in crude oil markets, global food commodity markets, the financial system, global supply chains) and their propagation to the broader economy. From a methodological point of view, students will learn how to implement simple macroeconometric techniques such as "local projections" in state-of-the-art statistical software and how to use these tools to answer policy relevant questions. The course thus provides a solid foundation for conducting independent research with a quantitative focus and for understanding recent contributions and discussions in the field of empirical macroeconomics.

#### **Course Description**

This module introduces students to the study of conflict background, dynamics of peacebuilding, and their relationship to foreign aid interventions in the Americas. It draws upon concepts from the general framework of foreign aid, conflict, and peace to understand specific cases where the interventions of foreign aid agencies play a significant role in the dynamics of peacebuilding, with particular attention to contemporary dynamics of the interrelations between these international actors and the local dynamics of conflict and peace. The module offers a hemispheric, interdisciplinary approach. It provides a foundational-to-intermediate level understanding of Political Science, International Relations, and Development Studies to provide students with a comprehensive understanding of the subject matter. Moreover, the module explores various types of foreign aid agencies, analysing their implementation approaches and the impact and effectiveness of their intervention. For instance, the impact of the United States Aid Agency for Development (USAID) or the European Union in postconflict countries. Therefore, the module employs comparative approaches in addition to specific case studies from South and Central America, such as Guatemala, El Salvador, Peru, or Colombia, to understand how the region of the Americas is currently facing interventions from foreign aid agencies and their respective challenges.

#### **About the Instructor**



Examination of regional and subregional security complexes in the region, and their interrelationships with societal political movements and involvement of international and global actors and factors. Examination of specific key issue areas, including characteristics and challenges of political structures and processes, and different security issues. These will include understanding political Islam in the region and its relationship with transnational jihadi; terrorist networks; civil wars and conflicts and their aftermath; the relationship between religious/ethnic identity, democratization, gender, state-building; the relationship between conflict, security and development; the politics and security of oil, gas and other natural resources in the region; and the regionally-specific challenges of arms control, disarmament and confidence-building.

#### **Course Description**

Independent Study Units (ISUs) aim at deepening the students' knowledge in a field of public policy, at an individual pace and are geared to pursuing individual interests. They may also serve as a means of allowing students to equalize differing levels of prior knowledge.

If you are interested in registering for an Independent Study Unit, please discuss its contents and how it fits into your study plan with your academic mentor and contact MPP Program Coordinator <u>Christian Tischmeyer</u> for more details regarding registration and the study agreement.

Subject to approval by the academic mentor, the Brandt School's academic staff as well as faculty members or professors of the Faculty of Economics, Law and Social Sciences or other faculties of the University may be approached as supervisors for an ISU.

According to Section 5, paragraph 3 of the framework regulations of Master programs at the University of Erfurt (M-RPO 2019), an independent study agreement must be signed by both the student and the instructor at the beginning of the semester (within the course registration deadline) to receive credit points for an ISU. In this independent study agreement, the student pledges to work on an agreed topic and corresponding questions regularly and independently as well as to spend the necessary amount of time to reach the learning goals within a given time frame. To check the learning progress and to give the instructor an overview of the working status, specific assignments are given and regular meetings should be agreed upon.

# Graduation Module: Research Colloquia

Students writing their master thesis need to participate in one of the colloquia, usually that of their first supervisor. Should your first supervisor not offer a colloquium, visit that of the second reader.

In case none of the two readers offers a colloquium, please get in touch with one of the instructors to ask about joining theirs, or with the MPP Program Coordinator for assistance. Make sure to consult your supervisor, e.g. during office hours.

While you need to register for a research colloquium, it is not necessary to also register on E.L.V.I.S. for the Master thesis itself!

# **Language Courses**

MPP students can choose from a great variety of language courses offered by the University's Language Center. In addition, the Brandt School offers special German beginners' classes for international MPP students.

- Students with no or little knowledge of German take German classes up until level A2.1 (CEFR)
- Students with A2 or higher-level knowledge of German continue improving their German language skills or opt for another foreign language on offer (e.g. Arabic, Chinese, English, French, Russian, Spanish)
- Also German native speakers improve their knowledge of a foreign language

In addition to courses, the Language Center also offers proficiency exams (Niveaustufenprüfungen) in several languages that you can take (regardless of whether you have taken a course or not) at the end of the lecture period, providing you with a certificate of your level. For current information, please check the Language Center's websites for the respective languages.



## **Language Module**

- Your study rules ("Studien- und Prüfungsordnung") require that you collect a total of 6 credits and a grade in the language module during your studies.
- This means that you can either take one course with 6 credits, or two courses with 3 credits each (3+3=6). Should you decide to take two courses, these must be conducted in the same language, advancing you (at least) one proficiency level in one language.
- Either way, you will have to do one module exam, providing you with a grade. You
  may take more courses in the language module, if you like.
- A large variety of language classes are offered by the University's Language Center (Sprachenzentrum). The list of offers is on their website or on E.L.V.I.S. (Summer Semester 24 > (ZS) > ZS Acquisition of a langue level 2020).
- Students who are not yet proficient in German (level "A2") must take the German language module.
- Check for schedule clashes with (mandatory) MPP courses, before signing up for a particular class via moodle (see <u>sign-up procedure</u>)!
- Some classes require a placement test beforehand; for the test dates see <a href="here">here</a>.
